Consent for Use and Disclosure of Information

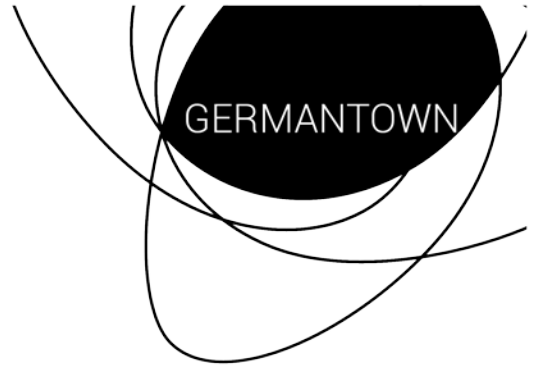

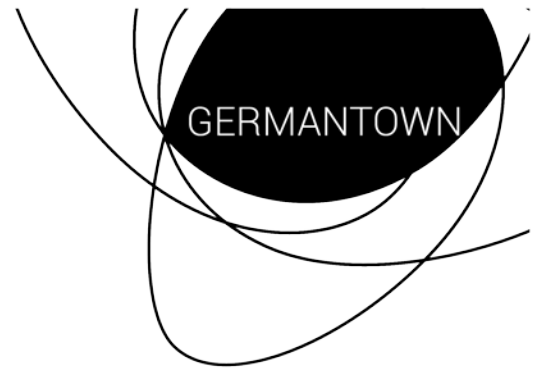
